Why a feminist party?

In Europe, every third woman has experienced physical violence since the age of 15. The gender pay gap is increasing in many countries and women are still forced to choose between parenthood and working. Discrimination and violence are part of everyday life for many LGBT people. We have seen hate speech against minorities from several political leaders, as well as an increase of fascist parties in all parliaments. Europe is guarding its borders while the need for people to seek refuge in Europe is greater than ever.

A new dimension in politics

There is a lack of political direction in order to tackle these challenges. The Feminist Initiative puts gender equality and human rights on top of the political agenda. Our ideas are based on antiracist feminism and we think that politics should be about more than economic growth. Left and right wing perspectives are not irrelevant, but discrimination, racism and sexism do not disappear automatically with socialism. Neither does liberalism, with its focus on individual freedoms, remove the structural inequalities of our societies. That is why the world needs ideologically independent feminist political parties.

The Feminist initiative in Sweden was founded in 2005 by feminists from the women's movement, the LGBT movement and the Antiracist movement, as well as students, academics, politicians and activists. From the first election in 2006 when the party gained 0,7 percent of the votes, the support for the party has increased to 3,2 percent of the votes in the 2014 elections. The party today has seats in 13 municipalities in Sweden. In the elections to the European parliament the party had 5,5 percent of the votes, gaining one seat and taking place in the committees LIBE, AFET and DROI, and joining the political group of Socialists and Democrats.

We work with feminist politicians across party lines to promote human rights and combat discrimination based on gender, skin color, ethnicity, social class, sexuality, functionality, sexual identity or religious belief.

We're actively looking for feminist and antiracist movements across Europe ready to take the next step. Starting a new political party is a big project - that's why we offer assistance and guidance on the ground. Let's do it together!
